



Cannelle Campus – €400 credit back

Effective from: 1st July 2026

This policy sets out the eligibility criteria, incentives, and conditions for students who book accommodation at Cannelle Campus under the conditions of the €400 credit back offer.

Under this scheme a student successfully booking accommodation and satisfying the requirements set out in this Policy will receive a credit back on their rent account of €400

The offer is only valid for room bookings under a Full Year (51 weeks) or Academic Year (45 Weeks) contracts.

Campaign Period

The €400 credit back campaign (also known as “Room Booked. Summer On” or “Sorted for Summer”) is open from 1st July 2026 until 31st August 2026.

All bookings must be submitted and completed during the campaign period to qualify. All bookings must use code AQ400CB.

Limited bookings are available under this promotion. Cannelle Campus reserves the right to close the campaign early once the allocated promotional budget or booking allocation has been reached. **How it Works**

1. Any student aged 18 years or over must complete a booking at Cannelle Campus through the Orla-Student.com website on or before the 31st August 2026.
2. Completing a booking requires both making the reservation fee payment and signing the contract.
3. The student must complete their move in and pay their first monthly instalment of rent.
4. Once all eligibility requirements have been met, a €200 credit will be added to the student account for the November monthly instalment and a €200 credit added for the February monthly instalment
5. All other instalments of rent will remain the same

Reward Payments

- Credits will be processed after eligibility checks have been completed and no later than 31st October 2026.
- No entitlement to payment arises until all eligibility checks have been completed and payment has been approved.

Payment Information and Data Protection

All payment credits will be made directly to the Orla Student online account.

There is no cash alternative to this reward.

All personal data will be processed in accordance with Regulation (EU) 2016/679 (the General Data Protection Regulation or "GDPR") and any applicable Italian data protection legislation.

Bank details and other personal information will only be retained for as long as necessary to administer the promotion, process payments, and comply with applicable legal, accounting, tax, and regulatory obligations.

Access to such information will be restricted to authorised personnel and service providers involved in administering the promotion.
